

## TENDER DOCUMENTS FOR SALE OF LAND SITUATED AT BRIJGHAT DISTRICT HAPUR

### TENDER DOCUMENT:

- (1) **ELIGIBILITY FOR BIDDING:** Individuals, firms, companies, trusts, or associations not declared insolvent.
- (2) **BIDDER INFORMATION AND DECLARATIONS:**
  - Identity and Address Proof: Self-attested copies of the bidder's identification and address proof, such as Aadhar Card, PAN Card, passport, etc.
  - Financial Capacity: Documents showcasing the bidder's financial soundness and capacity to meet the bid price i.e. proof of having a minimum of 20% liquid assets of the bidding price. This amount should be available in a bank account, FD, or bank credit limit as on the tender submission date.
  - Authority Letter/Power of Attorney (if applicable): If a representative is submitting the bid, an authorization letter or Power of Attorney is required.
  - Undertaking on Blacklisting: A declaration stating that the bidder has not been blacklisted by any government/semi-government organization or authority.
- (3) **EARNEST MONEY DEPOSIT (EMD):** ₹15,000 ( Rupees Fifteen Thousand Only) via Cash/Demand Draft payable at Meerut in the name of Manish Govil Memorial Trust/Cash Receipt as earnest money issued by Manish Govil Memorial Trust. In the event of failure to honour the bid by successful bidder, the earnest money will be forfeited.

### (7) PLOT DESCRIPTION:

The land comprises two adjoining plots:

- (1) 0.1892 hectares (2262.81 sq yards, Khasra No. 1589, Khata Nos. 469 & 00042) within Brijghat municipal limits, Tehsil Garhmukteshwar, District Hapur.

(2) 0.252 hectares ( 3013.89 sq yards, Khasra No. 1586, Khata No. 547) situated outside municipal limits in village Alamgirpur, Pargana & Tehsil Garhmukteshwar, District Hapur.

(3) Total area of the plot combining the above two plots is 5,276.70 sq. yards.

Although legally distinct but the two plots form a single contiguous parcel. The plot S.N. (1) is enclosed by a 34.5 cms wide, 6 ft high brickwork above-ground-level boundary wall, also soil filled up to 6 ft above natural ground level. Municipal sewerage infrastructure is available near the plot.

- (1) The bid must be unconditional and conform to the terms of the invitation.

- (3) Transparency and Due Diligence: Manish Govil Memorial Trust is open to transparency in the process, and the buyer should conduct thorough due diligence to verify the property and the seller's credentials.
